- 3. Diversion proposals of North Eastern Coalfields, Coal India Ltd.
  - The Expert committee constituted vide this office Order No.440, dtd. 06.07.2015
    has submitted the report recommending the proposal for approval by the Board
    subject to compliance of the set of mitigation measures suggested by the
    committee.

The Expert Committee report is placed before the Board during its 9<sup>th</sup> meeting and Board has recommended the project subject to implementation of the mitigation measures suggested by the expert committee.

- 4. Diversion of 98.59 ha in Saleki PRF under Digboi Division for Tikok OCP Coal mining project by North Eastern Coal fields, Coal India Limited, Assam.
  - The Expert committee has submitted the report and has recommended the proposal subject to implementation a set of mitigation measures.
  - The Member Secretary stated that the then DFO, Digboi Division vide his letter No. A/G-42/1501-40, dtd. 30.08.2013 reported CF, EAC, Jorhat that the Diversion of 98.59 ha. Of Forest land for Tikok open cast project in Seleki PRF under Digboi Division is outside 10 Kms. Radius of Dehing Patkai Wildlife Sanctuary. Hence, after discussion of the proposal, the member of the board suggested for verification and authentication of the distance by a Senior Forest Officer and on obtaining confirmation of the distance of the project area beyond 10 kms from Dehing Patkai Wildlife Sanctuary, the Chief Wildlife Warden will accepted the proposal for further processing and forward to Govt. of India.
