1. **Background/Context** : As per C&AG Report 40 of 2016, as on 31 March 2016; the Government had owed Air-India (AI) Rs.513.27 Crore towards VVIP's & other Chartered Flights and including evacuation fights and maintenance of aircraft, etc. Consequently, I have been periodically updating information on the said subject. Now F.Y. 2020-2021 has started; I am requesting through this RTI Application, duly updated information, as available in this Public Authority (PA), till the date of response.

Information Requested :

In the above background and context; **like in the past** - please provide me updated (till the date of response), complete and detailed information (including dates & Invoices etc.) : **(i)** Trip-wise amount to be paid / owed by different Public Authorities (PAs) of the Government to AIR INDIA towards VIPs / VVIP's Chartered Flights including Evacuation and Special Chartered AI Flights **(ii)** The detailed information to include the share of Maintenance of Aircrafts due for each VVIP/ Public Authority, **(iii)** VVIP's wise details of trips completed but Invoices/Bills under preparation OR still under process. **(iv)** Also Detailed information (including amount Levied, Paid/ Due - from the Government /PAs; with dates & Invoices etc.) requested for **Maintenance of newly acquired special VVIPs Aircrafts** - from the time these Aircrafts arrived in India.

Apart from information requested at Paras 2 above; kindly also provide me updated (till the date of response), complete and detailed information (including dates & Invoices etc.) Concerning **(i)** Public Authority-wise - Amount to be paid / owed by different Public Authorities (PAs) of the Government and Public Sectors or any other such Public Authority - to AIR INDIA **(ii)** From F.Y 2015-2016 onwards : Pease Provide Financial Year-Wise : information on the Amount not-recovered but Book Adjustments done. The detailed information to include dates with break-up of amount due from each such public authority **OR** information **in format as available / held in the records of the AI** (iii) Provide **Date of last Audit** done.
